I understand that my balance is due in full as of June 1, 2021. *Play-a-Round Golf* will notify me, via e-mail or phone if there is any outstanding balance at least seven days prior to this deadline. I agree to contact *Play-a-Round Golf* or make payment arrangements prior to June 1, 2021. If I apply after June 1, 2021, I understand that my balance is due within two weeks of my child starting camp and that cancellation within two weeks of camp may result in a refund of up to 50% of monies paid less the non-refundable deposit.

### Terms & Conditions

- Play-a-Round Golf* utilizes facilities entities which is to or does provide goods or services for your child's ("child") program including, for example, campus or golf facilities, such as golf courses, transportation companies, restaurants, food service, educational service providers, etc. As a result, *Play-a-Round Golf* is not liable for any negligent or willful act or failure to act of any such person, or of any other third party not under our direct control. Without limiting the foregoing, *Play-a-Round Golf* accepts no responsibility for any risk or resulting injury, delay, inconvenience, damage, or death which results from acts of government, nuclear reaction or incidents, criminal activity, weather or other acts of God, accidents, disease, epidemics or the threat thereof, illness, the provision of inappropriate or no medical attention or the lack of access to same, the demands of indoor or outdoor activities, activities engaged in by your child during free or unsupervised time, strikes, political or civil unrest, structural or other defective conditions in facilities, overbooking, acts of terrorism or the threat thereof, insurrection or revolt, or any other event beyond its direct control.
- Play-a-Round Golf* reserves the right to decline to accept any student for inclusion in a camp.
- I agree to ensure that my child and I will read the Rules and Policy statement and sign it. I will make every effort to ensure they understand it.
- I agree to pay for any charges imposed by any facility or any supplier of services based upon vandalism or destruction of property or other damage caused by my child.
- Any dispute concerning this or any other literature or any other form of communication concerning the Program, any oral representations or comments by *Play-a-Round Golf*, which relate thereto, or the Program itself, shall be resolved solely by binding arbitration in Chester County, Pennsylvania in accordance with the then existent commercial rules of the American Arbitration Association. In any such arbitration, the substantive (but not procedural) laws of the Commonwealth of Pennsylvania shall apply.
- Play-a-Round Golf* reserves the right to withhold a student from program activities if tuition has not been paid in full.

### Parent/Guardian Consent
